

PRAVILA NA STADIONU

1. Uvod
Ta pravila in predpisi (v nadaljevanju: pravila) skupaj z ustreznimi nacionalnimi zakoni in vsemi higienskimi ukrepi za preprečevanje širjenja okužbe s COVID-19, veljajo za vse imetnike vstopnic in akreditacij v vstopajo na območja stadiona, ki se uporabljajo v povezavi z finalnim turnirjem UEFA Under-21 prvenstvom Madžarska-Slovenija (v nadaljevanju: Turnir) po slovenski zakonodaji.

Prostori stadiona vključujejo vsa prizorišča, vključno z vsemi vhodi in izhodi, kot tudi vsa uradna območja in pripadajoči objekti (v nadaljevanju: stadion), ki so dostopna z vstopnico in/ali akreditacijo.

Vsi udeleženci so dolžni spoštovati in upoštevati navedena pravila.

2. Vhod
2.1 Vstop na stadion bo mogoč le ob predložitvi veljavne vstopnice in/ali akreditacije, izdane za vsako posamezno osebo. Vstopnico in / ali akreditacijo je potrebno na zahtevo varnostnega osebja (varnostnik, policist, itd.) ali druge uradne osebe UEFA in / ali NZS predložiti na vpogled in pregled ob vstopu na ali znotraj stadiona.

2.2 Imetnik vstopnice in/ali akreditacije je na zahtevo varnostnega osebja dolžan predložiti uradni dokument (osebna izkaznica, potni list, itd.).
2.3 Mladolletne osebe, mlajše od 14 let, lahko vstopijo na stadion z vstopnico le ob spremljevalcu odrasle osebe.
2.4 Veljavnost in uporaba vstopnice in/ali akreditacije se določita skladno s poslovanjem z vstopnicami / akreditacijami.
2.5 Vožnja in parkiranje vozil znotraj območja stadiona je dovoljeno z dovoljenjem UEFA in / ali NZS.

3. Osebnostna kontrola
3.1 Varnostno osebje ima pravico preverjati – tudi s pomočjo tehničnih pripomočkov – ali osebe predstavljajo varnostno tveganje (vpliv alkohola ali mamil, posest prepovedanih predmetov) ter imajo pravico preiskati oblačila in druge predmete v lasti osebe.

3.2 Osebnostni in neposredno uporabljivi predmeti in/ali akreditacija, ki ne ustrezajo navodil UEFA in / ali NZS (ali katere koli uradne osebe UEFA in / ali NZS), ali varnostnega osebja na stadionu, ali ki predstavljajo varnostno tveganje, se zavrne vstop na stadion in morajo organizatorju nemudoma vrniti svojo vstopnico in/ali akreditacijo skladno s pogoji poslovanja z vstopnicami in akreditacijami.

4. Vedenje na stadionu
4.1 Vse osebe ob vstopu na stadion morajo:
a) ravnati tako, da ne škodujejo, poškodujejo, ogrožajo, po nepotrebnem ovirajo ali nadlegujejo drugih, ali povzročajo škode;
b) spoštovati navodila UEFA in / ali NZS (ali katere koli uradne osebe UEFA in / ali NZS) ali varnostnega osebja na stadionu;
c) zasedati dodeljene sedeže, kot je navedeno na njihovi vstopnici ter uporabiti ustrezne dostopne poti;
d) upoštevati vse higienske ukrepe za preprečevanje širjenja okužbe s COVID-19;
e) ne smejo premlati opreme, inventarja ali naprav, prav tako je prepovedano nameščati kakršno koli opremo v brez predhodnega dovoljenja UEFA in / ali NZS;
f) takoj obvestiti UEFA in / ali NZS v primeru nastanka kakršne koli škode na premoženju ali o kakršnikoli nesreči.
4.2 Imetnik vstopnice in/ali akreditacije lahko dostopa le na območja, za katera mu je bilo izdano dovoljenje.
4.3 Pričakovano vedenje udeležencev / gledalcev (fair play):
a) spoštujate svojo ekipo s petjem in ustvarjanjem pozitivnega vzdušja;
b) spoštujete drug drugega, igralce in uradne osebe ekip, ter sodnike;
c) ne ustrajujete nasprotne ekipe, sodniške ekipe ali nasprotnih navijačev;
d) na igrišču / v druge obkroženosti, varnostno osebje ali druge udeležence ne mečite predmetov, tekočin ali drugih predmetov.
4.4 Za preprečevanje zmanjšanja ali odstranjevanja nevarnosti za življenje, zdravje ali premoženje se lahko zahtevajo dodatne zahteve. Neupoštevanje navodil varnostnega osebja ima lahko za posledico odstranitev iz stadiona.

5. Covid-19 ukrepi
5.1 Vse osebe, ki vstopajo na stadion, morajo pred vstopom na stadion in na stadionu:
5.1.1 ves čas zagotavljati varno razdaljo – na splošno 1,5 do 2 m od rame do rame na javnih mestih;
5.2 se udeležiti merjenja telesne temperature in izpolniti zdravstveni vprašalnik o možnih COVID-19 simptomih;
5.3 ves čas nositi higiensko masko (pokriva usta in nos);
5.4 uporabljati sredstva za razkuževanje rok (na veljavo na vseh dostopnih mestih na stadionu in vseh vstopnih mestih na vse cone);
5.5 upoštevati druge ukrepe in priporočila, ki bodo veljala na dan vstopa na območje stadiona.

6. Zvočni in slikovni posnetki in prenosi
6.1 Vse osebe, ki vstopajo na stadion, morajo pred vstopom na stadion in na stadionu:
6.1.1 Vor na turnirju udeležene osebe soglašajo s fotografiranjem ali snemanjem iz strani UEFA in / ali NZS (in/ali druge uradne osebe UEFA in / ali NZS). Le-ta ima pravico do uporabe, predvajanja, objavljanja in licenciranja vseh posnetkov brez plačila ali druge oblike nadomestila za uporabljen video in zvočne posnetke, oddajanje ali druge oblike predvajanja, snemanja, uporabe fotografij ali druge sedanje ali prihodnje oblike medijev ali tehnologije.
6.2 Vsem na turnirju udeleženi osebam je prepovedano snemanje in/ali predvajanje zvočnega in video materiala in prikazovanje stadiona ali tekme (tudi rezultata, statistike tekme), razen za lastno in osebno uporabo. Prepovedano je spletno, radijsko ali televizijsko predvajanje in/ali predvajanje v obliki kakršnih koli sedanjih in/ali prihodnjih medijev, kot tudi deliti ali nuditi pomoč drugi osebi pri deljenju zvoka, slike, posnetka, podatka, opisa, rezultata in/ali statistike tekme.

7. Prepovedani predmeti in obnašanje
7.1 Na stadion je prepovedano vnašati naslednje predmete:
a) alkohol, droge ali druge prepovedane substancije;
b) vse vrste orožja ali eksplozivov. Tudi predmete, ki se lahko na kakršen koli način uporabljajo za rezanje, zabijanje ali poškodovanje oseb;
c) živali (razen policijskih psov in psov vodilcev);
d) steklenice, kozarce (narejene iz steklovine ali podobnega materiala), pločevinke ali druge predmete, ki so lahko potencialno nevarni za napad ali metanje;
e) pirotehnične izdelke v vsoti oblikah ali naprave s prepovedano snovjo (petarde, dimni prah / bomba, itd.);
f) pištolne razpršilnice s korozivnimi, vnetljivimi snovmi, barvilni ali posode, ki vsebujejo škodljive snovi nevarne za zdravje, ali pa so zelo vnetljive;
g) mehanske ali elektronske zvočne naprave, ki proizvajajo zvok, ki lahko vpliva na varnost na prireditvi (megafoni, vuvuzelas, trumpeci, itd.);
h) obrazne maske ali druga pokrivala, ki preprečujejo identifikacijo, in motorne ali druge čelade. Izjema so obrazne maske, potrebne za upoštevanje higienskih ukrepov (pokrivanje nosu in ust);
i) zastave in napise večje od 2,0 x 1,5 m, trde nosilce-drogove in vse vrste nosilcev ali napisov;
j) laserske naprave;
k) brezpilotne letalnike (drones) in druge podobne naprave;
l) žoge in balone;
m) večje nahrbtnike, večje torbe, potovalne torbe ali kovčke (večji od 25x25x25 cm);
n) predmete, kot so lestve, (zložljivi) stoli, vozčki, škatle, velike torbe, nahrbtniki, kovčki in športne torbe;
o) fotoparate in video kamere ali podobne naprave za profesionalno uporabo;
p) rasistične, xenofobne, opolizemske, provokativne, religiozne ali politične propagandne predmete ali materiale;
q) vse predmete, ki niso primerni za tovrstno prireditvi in jih je mogoče uporabiti za metanje, povzročanje škode na športni infrastrukturi ali osebah (npr. papirnate brizače ali večje količine papirja, dežniki, itd.), in s strani UEFA in / ali NZS neodobren material (npr. promocijski material ali oblačila, itd.);
r) katere koli predmete, za katere varnostno osebje meni, da so potencialno nevarni za varnost na prireditvi.
Zgorajni seznam prepovedanih predmetov ni dokončen. Varnostno osebje in uradne osebe UEFA in / ali NZS bodo v primeru dvoma določili kateri predmeti so prepovedani ali dovoljeni.

7.2 Brez omejitev je na stadionu strogo prepovedano:
a) metati kakršnekoli predmete ali tekočino, še posebej v smeri druge osebe ali na območje okoli igralne površine ali na samo igralno površino;
b) zanetiti ogenj, izpustiti ognjemet, rakete ali drugo pirotehniko;
c) izriniti ali širiti politično, religiozno, rasistično, xenofobno, opolizemsko propagando, slogane ali znake;
d) nametati na način, ki si ga lahko drugi razlagajo kot provokativen, grozeč, diskriminatoren ali žaljiv;
e) prodajati blago in vstopnice, deliti tiskano gradivo ali izvajati druge promocijske ali komercialne dejavnosti brez predhodnega soglasja UEFA in / ali NZS (ali uradne osebe UEFA in / ali NZS);
f) vstopiti na igralno površino ali njeno območje;
g) plezati na ali sed na konstrukcijah in napravah, ki temu niso namenjene;
h) pisati, risati ali kar koli pritrdjevati na strukturne elemente, naprave ali poti;
i) opravljati potrebo kjer koli drugje kot v toaletnih prostorih, ali odmetavanje predmetov kot so smeti, embalaža, prazne posode, itd.
j) stati na sedežih;
k) kakršno koli drugo ravnanje, ki je prepovedano ali nevarno ali ogrožljivo.
7.3 Na celotnem območju stadiona je kajeenje strogo prepovedano. Prepovedana je tudi uporaba elektronskih cigaret.
7.4 Brez dovoljenja UEFA in / ali NZS (ali uradne osebe UEFA in / ali NZS), je znotraj stadiona brez omejitev strogo prepovedano:
a) vstopati na območja (npr. uradni prostori, VIP in medijski prostor, itd.), ki so zaprta za javnost ali vstop ni dovoljen;
b) zdrževanje na območjih namenjenih prometu, pešpotah ali cestah, vstop in izhodi na območjih za obiskovalce, in zastin izhodi;
c) kakršno koli drugo prepovedano ravnanje.
7.5 Za vsako kršitev teh pravil se lahko izrečejo naslednje kazni:
a) odstranitev iz stadiona in predviden nadaljnji postopek policije;
b) preključitev vstopnice in prepoved vstopa na vseh naslednjih tekmah turnirja organiziranega od UEFA in / ali NZS;
c) posredovanje osebnih podatkov nacionalnim nogometnim zvezzam in/ali policiji, da lahko sprejmejo ustrezne ukrepe, npr. prepoved vstopa;
d) organizator UEFA in / ali NZS ali njegova uradna oseba lahko uvede ustrezne pravne postopke;
e) druge kazni ali pravna sredstva v skladu z veljavno zakonodajo.

UEFA in / ali NZS si pridržuje vse pravice do uveljavljanja drugih pravnih sredstev po lastni presoji.
7.6 UEFA in / ali NZS si v primeru višje sile na katero nima vpliva (vremenski in drugi pojavi ali vzroki), pridržuje pravico do spremembe datuma in ure tekme.

8. Odgovornost
Vsaka oseba se tekme udeležuje na lastno odgovornost in je odgovorna za nastalo škodo ali izgubo, ki je posledica njenih dejanj na stadionu.

9. Dodatne določbe
9.1 Če pristojno sodišče katero od določb teh pravil razglasi za nično, neučinkovito ali neizvršljivo, preostale določbe pravil ostanejo v veljavi, kot da takšna nična, neučinkovita ali neizvršljiva določba ne bi bila vsebovana.
9.2 Organizator si pridržuje pravico do občasne ustrezne spremembe pravil, katerih novejša in učinkovitejša različica bo na voljo na uradni spletni strani NZS ter na stadionu.
9.3 Med turnirjem imajo ta pravila prednost uveljavljanja pred interimi pravili stadiona.

10. Verodostojnost vsebine
Pravila so bila sestavljena v slovenskem jeziku in prevedena v angleški jezik. V primeru neskladja med besedili, se uporablja slovensko besedilo.

11. Veljavna zakonodaja in pristojnost
11.1 Pravila ureja in razlaga slovenska zakonodaja.
11.2 Vsi sponi, izhajajoči iz pravil ali povezani s pravili, se predložijo pristojnemu sodišču v Sloveniji.

12. Prepovedani predmeti
Glej priloženi piktoqram.

STADIUM RULES

1. Scope
These Stadium Rules and Regulations (hereinafter "Rules"), together with the relevant national laws and all hygiene measures to prevent the spread of COVID-19 infection, shall apply to all Ticket and/or Accreditation holders who enter stadium premises used in connection with the final tournament of the UEFA European Under-21 Championship Hungary-Slovenia 2021 (hereinafter "Tournament") according to the laws of Slovenia.

Stadium premises shall include all venue areas, including all entrances and exits, as well as all other official areas and facilities (hereinafter "Stadium") that are accessible with a ticket and/or accreditation.

All participants are obliged to respect and follow these Rules.

2. Entrance
2.1 Entrance to the Stadium shall only be authorised upon presentation of valid Ticket and/or Accreditation for each individual person. The Ticket and/or Accreditation must be shown and handed over for inspection on entry control and inside the stadium at the request of any security personnel (steward, police officer, etc.) and/or other personnel authorised by UEFA and/or the Slovenian FA.

2.2 The ticket and/or accreditation holder is obligated to present an official identity document (identity card, passport, etc.) on request by security personnel.
2.3 Minors under the age of 14 shall enter the Stadium with a valid ticket accompanied by adult.
2.4 The validity and usability of Tickets and/or Accreditations shall be determined according to the Ticketing / Accreditation Terms and Conditions.
2.5 Driving and parking of vehicles inside the Stadium perimeter shall only be permitted with the special authorisation of UEFA and/or the Slovenian FA.

3. Personal controls
3.1 Security personnel shall be entitled to examine – including through the use of technical aids – whether persons represent a security risk (the influence of alcohol or drugs, possession of prohibited items), and shall be entitled to search any person's clothing and other items in their possession.

3.2 Persons who make an unauthorised use of Tickets and/or Accreditations, who do not follow the instructions of UEFA and/or the Slovenian FA (or any official appointed by UEFA and/or the Slovenian FA) or any security personnel at the stadium, or who represent a security risk shall be denied access to the Stadium and shall immediately return their Ticket and/or Accreditation to UEFA and/or the Slovenian FA, in accordance with the Ticketing / Accreditation Terms and Conditions.

4. Conduct inside the Stadium
4.1 All persons entering the Stadium shall:
a) conduct themselves in such a way that they do not harm, injure, endanger or unnecessarily obstruct or annoy others, nor cause any damage;
b) follow the instructions of UEFA and/or the Slovenian FA (or any official appointed by UEFA and/or the Slovenian FA) or any security personnel at the Stadium;
c) occupy the seat allocated to them as described on their Ticket and use the appropriate access routes;
d) comply with all hygiene measures to prevent the spread of the COVID-19 infection;
e) not move equipment, inventar and devices in the room where it takes place event, and it is forbidden to install any equipment without the prior permission of UEFA and/or the Slovenian FA;
f) immediately notify UEFA and/or the Slovenian FA in case of any damage caused to any property or an accident of any kind.
4.2 The ticket and / or accreditation holder is entitled to access only to the areas for which the entry permission has been issued.

4.3 Expected behaviors of participants / spectators (fair play):
a) encourage your team by singing and creating a positive atmosphere;
b) respect each other, the players and team officials and the referee team;
c) do not intimidate or frighten the opposing team, the referee team or opposing supporters;
d) do not throw any kind of objects, liquids and other objects to the pitch, other visitors, security personnel or other participants.
4.4 Further exceptional demands may be made in order to prevent, reduce or eliminate danger to life, health or property. Instructions issued by security personnel must be followed and failure to cooperate may result in expulsion from the Stadium.

5. General Covid-19 measures
5.1 To prevent the spread of COVID-19 infection all participants before entering the Stadium and inside the Stadium shall:
5.1.1 provide a safe distance at all times – in general 1.5 to 2 m shoulder to shoulder is the required in public places;
5.2 attend body temperature measurements and fill out medical questionnaires about possible COVID-19 symptoms;
5.3 continuously wear a face mask (covering mouth and nose);
5.4 use a hand sanitizer (will be provided in all access points in the Stadium and all entry points to all zones);
5.5 consider other measures and recommendations that will apply on the day of entry into stadium perimeter.

6. Sound and image recordings and transmissions
6.1 All persons attending the Tournament consent to being photographed, filmed, or taped by UEFA and/or the Slovenian FA (and/or by and third parties appointed thereby) which shall have the right to use, broadcast, publish and license, without any requirement for payment of money or other form of consideration, of such person's voice, image and likeness by means of live or recorded video and/or audio display, broadcast or other transmission or recording, photographs or any other current and/or future media technologies.

6.2 All persons attending the Tournament shall not take record and/or transmit any sound, image and/or description of the Stadium or match (as well as any real and/or statistics of the match) other than for his/her exclusive, private, and domestic use. It is strictly forbidden to disseminate over the Internet, radio, television or any other current and/or future media, any sound, picture, image, data, description, result and/or statistics of the match in whole or in part or to assist any other persons conducting such activities.

7. Prohibited items and conduct
7.1 The following items shall not be brought into the Stadium:
a) alcohol, drugs or other psychoactive substances;
b) all kind of weapons or explosives. Also, any kind of objects, that may be used for cutting, stabbing, punching or injuring persons in any way;
c) animals (except police dogs and service animals to aid guests with disabilities);
d) bottles, jars (especially made of glass or a material that has the same properties), cans or other objects that are potentially hazardous and may be used as weapon for attack or as a metal object;
e) pyrotechnic devices in any kind form or device with prohibited means (firecrackers, smoke dust / bombs, etc.);
f) gas spray cans with corrosive, flammable substances, dyes or receptacles containing substances which are harmful to health or are highly flammable;
g) mechanical or electronic sound devices, which produce sounds that may affect safety and security at the event (mega-phones, vuvuzelas, air-horns, trumpets, etc.);
h) face masks or other headgear that allow people to hide their identity, and motor or other helmets (exceptions are face masks required for compliance with sanitary regulations – covering the nose and mouth);
i) flags and inscriptions larger than 2.0 x 1.5 m, hard flagpoles and all types of brackets or inscriptions;
j) laser devices/pointers;
k) drones and other similar devices;
l) balls and balloons of any kind;
m) larger backpacks, large bags, travel bags or suitcases (larger than 25x25x25 cm);
n) cameras and video cameras or other similar devices for professional use;
o) cameras and video cameras or other similar devices for professional use;
p) racist, xenophobic, vulgar, provocative, religious or political propaganda objects or materials;
q) all objects that are not typical of these types of events and could be used for throwing, causing damage to sports infrastructure or persons at an event (e.g. paper fans or larger quantities of paper, umbrellas, etc.), and all materials not authorised by UEFA and/or the Slovenian FA (e.g. promotional material or clothing, etc.);
r) any other items that security personnel believe are potentially dangerous, regardless of safety and security at the event;

The above list is not exhaustive. In case of any doubt with regards to any object being brought to the Stadium, the relevant security personnel or official appointed by UEFA and/or the Slovenian FA shall be responsible for defining which objects are prohibited or permitted.
7.2 Without limitation, it is strictly forbidden to do any of the following inside the Stadium:
a) throw objects or liquids of any kind, particularly in the direction of another person or in the direction of the area around the pitch or the pitch itself;
b) start a fire, let off or launch fireworks, flares, or other pyrotechnics;
c) express or disseminate political, religious, racist, xenophobic, vulgar propaganda and pursuits or slogans and emblems;
d) act in a way which may be interpreted by others as provocative, threatening, discriminatory or offensive;
e) sell goods and tickets, distribute printed material and hold collections or carry out other promotional or commercial activities without prior written authorisation from UEFA and/or the Slovenian FA (or any official appointed by UEFA and/or the Slovenian FA);
f) enter the pitch or the area around the pitch;
g) climb on, or over, structures and installations not expressly intended for that use;
h) write, paint on or affix anything to structural elements, installations or pathways;
i) relieve oneself anywhere other than in the toilets, or litter the Stadium by discarding objects such as rubbish, packaging, empty containers, etc.;
j) stand on seats in the spectators areas;
k) any other conduct which is prohibited or is dangerous or threatening.
7.3 Smoking is strictly prohibited in all areas of the Stadium. The use of electronic cigarettes is also forbidden.
7.4 Unless otherwise authorised to do so by UEFA and/or the Slovenian FA (or any official appointed by UEFA and/or the Slovenian FA), it is strictly forbidden to do any of the following inside the Stadium, without limitation:
a) access areas (e.g. official rooms, VIP and media areas, etc.) which are closed to the public or for which access is unauthorised;
b) restrict or litter in areas open to traffic, footpaths and roadways, entrances and exits to visitor areas and emergency exits;
c) any other conduct which is prohibited.
7.5 Any breach of the Rules may result in the following penalties being imposed:
a) expulsion from Stadium and a possible report being made to the police;
b) cancellation and invalidation of the match ticket and banning of the offender from all next matches of the Tournament organised by UEFA and/or the Slovenian FA;
c) provision of the relevant personal information to respective national football associations and/or the police so that appropriate measures can be taken, e.g. national stadium bans;
d) initiating by UEFA and/or the Slovenian FA or any other authorised persons or entities of legal proceedings;
e) any other penalties or remedies in accordance with applicable laws.
7.6 UEFA and/or the Slovenian FA reserves all other rights to pursue other legal remedies at its own discretion.

7.6 UEFA and/or the Slovenian FA reserves the right to change the date and time of the match in case of so-called force majeure, especially when this is due to weather or other causes beyond the control of UEFA and/or the Slovenian FA.

8. Liability
Any person attending the Tournament acknowledges that he/she does so at their own risk and that he/she may be liable for damage or loss resulting from any of his/her acts at the Stadium.

9. Severability and amendments
9.1 Should any provision of the Rules be declared void, ineffective or unenforceable by any competent court, the remainder of the Rules shall remain in effect as if such void, ineffective or unenforceable provision had not been contained.
9.2 UEFA and/or the Slovenian FA reserves the right to make reasonable amendments to the Rules from time to time, the latest and effective version of which shall be available on FAS official website and at the Stadium.
9.3 During the Tournament, these Rules shall take precedence over the internal rules of the Stadium.

10. Authentic text
The Rules have been drafted in Slovenian and translated into English. In the event of any discrepancy between the texts, the Slovenian text shall prevail.

11. Applicable law and jurisdiction
11.1 The Rules shall be governed by and interpreted in accordance with the laws of Slovenia.
11.2 All disputes arising from or related to the Rules shall be submitted to the competent court in Slovenia.

12. Prohibited items
See attached pictogram.
